Until the return is accepted as complete by Controllers on Call, dba InfiSoft Software ("InfiSoft"), and all additional copies have been destroyed, you must abide by the terms of this license.

License: You are granted a nontransferable, nonexclusive license ("License") to use the enclosed program and all enhancements, modifications, and updates to the program and all related written materials (the "Software") subject to this agreement. If the Software is purchased with a Single User License you may use one copy of the Software on a single computer at a single location. If the Software is purchased with a Multi-User License you may use the Software on a Single local area network server or central computer, which may serve the number of users at a single location for whom the license has been purchased.
